## Pathways to CPA Licensure initiative in Iowa

Ardis Kelley is chairing the ISCPA Pathways to CPA Licensure Task Force, a member group charged with exploring various stakeholders' views on the 150 hour requirement for CPA licensure in Iowa.

#### As the chair of ISCPA's Pathways to CPA Licensure Task Force, please share more about its purpose.

As you know, ISCPA continues to advance various initiatives that address the CPA pipeline issue that is an immediate and growing concern in Iowa. At the request of ISCPA's board of directors, a task force was formed to address pipeline issues with a specific lens on the 120/150 hour education requirement and its impact on students, graduates, and mobility of Iowa CPAs.

The Pathways to CPA Licensure Task Force (Pathways), comprised of a cross section of members representing various constituencies, held its initial meeting in June. Subcommittee meetings across 10 stakeholder groups are now underway. Through the use of data, focus group meetings across the state, and member surveys, the Pathways group will develop a recommendation on the 120/150 hour education requirement in

lowa and present to the board of directors in December for consideration and next steps.

Why is this important for ISCPA members? We need to preserve and grow the number of CPAs entering and remaining in the profession in Iowa and do so without compromising the perception of the CPA license, and without inviting questions about the quality of new CPAs or the value CPAs bring to all aspects of business, industry, and users of financial statements.

#### How can members voice their

opinions? Pathways, along with ISCPA leadership, will seek input through focus groups and membership surveys. Members across the state are encouraged to participate. Of course, you can also reach out directly to any member volunteering for Pathways or to ISCPA staff.

**to share?** This is an exciting time for the profession as various states are coming together to address the pipeline issue

and make meaningful and impactful changes for the good of our industry. I'm thrilled to be a part of this movement and excited to see the impact Iowa CPAs will have on the issue.
