## Iowa CPA Education Foundation Scholarship

### Overview

The Iowa CPA Education Foundation provides \$2,500 scholarships to Iowa college students pursuing an accounting degree with a goal of becoming a CPA.

### Eligibility Requirements

Eligible applicants must meet or complete the following:

- Attending an NCA and/or AACSB accredited educational institution in Iowa during the next academic year.
- Be an Iowa resident (home address in Iowa).
- Have not taken the CPA exam, but plan to take the exam in Iowa.
- 3.0 GPA or better.
- Have completed at least 60 semester hours of college credit, including 15 semester hours in accounting. (Does include principles of accounting.)
- Confirm your intent to take the written CPA examination conducted by the Iowa Accountancy Examining Board for the purpose of being granted a Certified Public Accountant certificate.
- Provide an essay (500 words or less) on why you want to become a CPA.
- Be a student affiliate member of the Iowa Society of CPAs (ISCPA). Student affiliate membership is free and can be completed at [www.iacpa.org](http://www.iacpa.org).



### Application Process

1. Any student meeting the eligibility requirements may complete a scholarship application.
2. Submit the completed application to the appropriate college professor or individual who acts as the liaison for the Iowa Society of CPAs.
3. The professor or liaison will select ONE application per school for scholarship consideration.
4. Professor or liaison will submit application and other required documents (see checklist) to ISCPA.
5. Applications must be received (not postmarked) by 5 p.m. on Feb. 15. Late applications will not be accepted.

7. Professor or liaison will be notified if student has been selected for scholarship.
